Agricultural Census has been conducted on quinquennial basis since 1970-71 by the Government of India, Ministry of Agriculture as part of the World Agricultural Census organized by the Food and Agriculture Organisation (FAO) of the United Nations. So far, Nine Agricultural Census exercises have been completed and this publication is the outcome of the Second Phase Of Tenth Agricultural Census (2015-16) which contains valuable information on the number and area of operational holdings, tenancy, land utilization, cropping pattern and crop-wise irrigated and un-irrigated area. The data on land holding covers the number of operational holdings according to social groups and institutional holdings.

This report reveals the vital aspects of agriculture and important factors influencing agricultural sector. We hope that this report would be useful for persons/organizations, those who are associated with the development of Agriculture in the country. This report will also be useful for policy formulation and planning for future agricultural projects.

I would like to record my appreciation for the support rendered by the Village Administrative Officers at micro level with the overall involvement of the District Collectors. I also wish to convey my thanks for the co-operation and assistance extended by the officials of the Government of India, NIELIT, and Personnel of the Department of Economics and Statistics without whose wholehearted efforts this report would not have been possible.

CHAPTER - 1

Introduction

Agricultural Census is carried out once in five years on a quinquennial basis involving collection of quantitative as well as qualitative data covering different agricultural activities.

Part-I of the Report on 10th Agricultural Census was already released covering the following principal characteristics of agricultural operations:

Number and Area of operational holdings

Size Classes - Marginal, Small, Semi-medium, Medium and Large

Social Groups - Scheduled Caste, Scheduled Tribe and Others

Type of holdings - Individual, Joint and Institutional Holdings

Part-II of the Report on Agricultural Census deals with:

Distribution of holdings according to tenancy status

Area under different land uses

Distribution of holdings according to irrigation status

Area under principal crops

Collection of these data is based on a Sample Survey of 20% of the Villages in the State selected under "Timely Reporting Scheme" during 2015-16.

Information relating to the above characteristics are compiled from the respective village land records covering all the cultivators. On the basis of these data, different tables containing various details are generated and annexed to this report.

1.1 Concepts and Definitions

1. Operational Holdings:

An 'operational holding' is defined as all the lands, which are used wholly or partly for Agricultural Production and is operated as one technical unit by one person alone or with others without regard to the title, legal form, size or location.

Land holdings have been classified into five broad categories viz:

Category	Size of holdings (in ha)
Marginal	Upto 0.99
Small	From 1.00 to 1.99
Semi-Medium	From 2.00 to 3.99
Medium	From 4.00 to 9.99
Large	From 10.00 and above

2. Operated Area:

Operated Area includes both cultivated and uncultivated area, provided that part of it is put to agricultural production during the reference period. For instance, if an operational holding consists of four survey numbers, out of which one survey number is put to non agricultural uses, the total area of the operational holding is equal to the total geographical area of all the four survey numbers. It also covers the land occupied by farm buildings, including the house of the holder, provided such buildings are within the cultivated area. If the farm buildings are located outside the cultivated area and are covered under abadi area, such buildings are not included. Operated area excludes Government forestland, Government wasteland, Village common grazing land, abadi area etc.

If the Government wasteland is allotted to an individual, then it is included in the holding. If the entire area of the holding (the area of all the survey

numbers of an operational holding) is put to non-agricultural use and or it is under old fallow, it is not considered as operated area. If however, the entire area of operational holding is under current fallow during the reference year, this is still considered as operational holding. In some cases, land is divided among all the members of the family. When it is divided between the husband, wife and minor children and the cultivation is being done by the husband as the head of the family, then the land is appropriately be treated as one operational holding. There are cases where in the records, a holding is shown jointly in the name of more than one co-sharer while in fact the land has been privately divided and the co-sharers are independently cultivating. In such cases where there is no dispute, they are treated as many operational holdings as the number of independent cultivators. For cultivated areas in State Forests landno detailed land records are prepared. In the absence of revenue records and revenue agency, such areas are excluded for census purpose.

3. The operated holding consists of:

- a) Land owned and self operated
- b) Land leased in
- c) Land otherwise operated

a. Land owned and self operated:

(i) **Land owned** means a piece of land, which the cultivator has the right of permanent heritable possession. This includes land held from Government or others under grant or lease or assignment with right of permanent heritable possession with or without right of transfer and land operated under perpetual lease.

(ii) **Self Operated Land** means a piece of land cultivated by the cultivator himself or cultivated through members of his family and land cultivated with the help of hired labourers. It will not include, land leased out to others.

(b) Land leased in:

Land leased in is defined as a piece of land taken on lease from others without any permanent right of possession for the lessee. Land may be leased in for Fixed money, Fixed produce, Share of produce and Usufructuary mortgage.

(c) Land otherwise operated:

This includes encroached land, forcibly occupied land, unauthorized possession or possession of land in dispute etc. which cannot be treated as owned or leased in as per the definitions given above.

4. Operational holder:

An operational holder is the person who has the responsibility for the operation of the agricultural holding and exercise the technical initiative. He has full economic responsibility or shares it with others. The operational holder may be Individual / Joint / Institutional.

(a) Individual Holding:

If the holding is operated either by a single person of a family or by a group of persons who are the members of the same household, is considered as an Individual holding.

(b) Joint Holding:

If two or more persons belonging to different households, share jointly as partners in the economic and technical responsibility for the operation of an agricultural holding, such holding is considered as Joint holding.

(c) Institutional Holding:

Holdings such as government farms, lands of co-operative sugar mills, co-operative farms, lands managed by trusts, etc. are treated as Institutional holdings.

5. Resident and Non-Resident operational holder:

(a) Resident operational holder: All the cultivators residing in a particular village and cultivating some piece of land are resident cultivators of that village

irrespective of the fact whether they cultivated land within that village or outside. A resident cultivator may have:

- entire area of the holdings in the village of his residence,
- partly within the village of his residence and partly outside
- entirely outside the village of his residence.

(b) **Non-Resident operational holder:** An operational holder operating some land outside the taluk in which the village of his residence falls is not treated as a resident cultivator for that village. He is treated as a resident cultivator of the village outside the taluk where the area of his operation falls.

6. Complete / Part holding:

A holding is said to be complete if the entire operated area of that holding is located in one village; and if the operated area is spread over more than one village, it would be considered as part holding. Taluk would be taken as the outer limit for consideration of part holdings.

7. Wholly irrigated, partly irrigated and wholly un-irrigated holding:

If the entire net area sown in an operational holding is equal to net area irrigated, such holding is considered as a wholly irrigated holding. In case part of the net sown area is irrigated, it will be called partly irrigated and if the entire sown area has not received any irrigation during the year of reference, such holding is considered as wholly unirrigated.

8. Land utilization:

Operation of land is classified into following nine broad categories:

(a) **Net area sown:** Out of the total geographical area, the Net area sown represents the area sown under first crop during the fasli year.

(b) **Current fallow:** Lands that are kept fallow out of the net area sown during the previous year are classified as current fallow for the reporting year.

(c) **Other fallow lands:** Lands which were taken up for cultivation but have been temporarily put off cultivation for a period of not less than one year

but not more than five years due to poverty of the cultivators, in-adequate supply of water, silting of canals and rivers, etc. are treated as other fallow lands.

- (d) **Permanent pasture and other grazing lands:** All grazing lands whether they are permanent pastures or meadows are considered as permanent pastures and other grazing lands. Village common and grazing lands within the forest area are included under this category.
- (e) **Land under miscellaneous tree crops:** All cultivable lands, which is not included under net area sown, but is put to some other agricultural use such as lands under casuarina, eucalyptus, teak, bamboo bushes, babul, thatching grass and other groves for fuel etc. which are not included under orchards and which bear yield only once in its whole life span are classified under this category.
- (f) **Culturable waste:** All lands available for cultivation whether not taken up for cultivation or taken up for cultivation once, but not cultivated during the current year and continuously for the last five years or more in succession for one reason or the other are classified as culturable waste. Such lands may be either fallow or covered with shrubs and jungles which are not put to any use.
- (g) **Barren and unculturable Land:** Lands which cannot be brought under cultivation unless at a high cost whether such land is in isolated blocks or within cultivated holdings, such as mountains, deserts, hills etc. are classified as barren and unculturable land.
- (h) **Forest:** Forest represent all actually forested area on the lands classed or administered as forest under any legal enactment dealing with forest, whether state owned or private. Only cropped area in private forest is covered for the purpose of agricultural census.

(i) Area under non-agricultural use: The land put to use for purposes other than agriculture such as buildings, pathways, roads, social forests, bus stands, railway tracks, canals, rivers, local reservoirs, swamps, marshy and water logged areas, lands under still water etc. are brought under this category. However, such lands within the cultivated holding are covered in the census.

1.2 Conduct of Phase-II Operation

The Phase-II operation relates to the collection of data on land characteristics in respect of each operational holding in 'H' Schedule. The details of principal characteristics of holdings viz. tenancy status, land utilisation, irrigation status and area of crops grown are collected in 'H' Schedule.

Schedule 'H' is to be filled in for all resident cultivators of the 20% sample villages only. The details for H Schedule would be collected from the revenue records for each khasra number operated by a particular operational holder. After covering all the Khasra numbers of one operational holding, the VAO would strike totals of all the columns. If the resident cultivator is operating some lands outside the sample village, details of such lands with all the characteristics would have to be obtained by the Village Administrative Officer at the resident cultivator village from the VAO of the outside the sample village in Schedule H and these should also be added to the Khasra numbers of that operational holding in the village where the operational cultivator resides. Extent of land operated by the resident cultivator outside the village would be available from schedules L-2 received for compiling Table1 (T table). Separate Schedule H would be filled in for each operational holder in the sample village.

There may be some non-resident operational holders who are operating some land in the sample village, but residing outside the taluk such non-resident

operational holders would be treated as if they are residing in the same village and their holdings would be pooled in that particular village.

Schedule 'H' is divided into seven blocks as detailed below:

- A1 Identification particulars
- A2 Particulars of operational holder
- B Area operated by tenancy status
- C Land Utilization
- D1 Crop wise area (Other than Horticulture crops)
- D2 Crop wise area (Horticulture crops)
- D3 Area under all crops

Fieldwork and Compilation of data

The field work was carried out by the Village Administrative Officers of the respective villages. The field work and compilation of 'H' data for 20% selected villages covering 3458 villages, commenced in June 2017 and was completed in December 2017.

The filled in schedules were thoroughly scrutinized by the respective Block Statistical Inspectors and Divisional Assistant Directors of Statistics under the overall supervision of the District Deputy Directors of Statistics and Regional Joint Director of Statistics.

Data collected in 'H' Schedules have been collated separately for the operational holdings of different social groups such as Scheduled Castes, Scheduled Tribes, Others and Institutional.

CHAPTER - 2

ANALYSIS OF 2015-16 RESULTS

2.1 Operational Holdings by Tenure Status in 2015-16

Comparison of Wholly owned and self operated (in percentage)




The Table 2.1.1 shows that the tenure category of wholly owned and self operated holdings, which constitute 99.76% of the total operational holdings in 2015-16 cover 99.58% of the total operated area in the state.

The tenure category of wholly leased in holdings is 0.12% during 2015-16 which shows a decrease of 0.02% when compared to 2010-11.

The average operated area per operational holding in the



has increased from 0.67 ha. to 0.90 ha. and 1.61 ha. to 2.05 ha. respectively in 2015-16. Average operated area per operational holding in the case of wholly owned and self operated and wholly otherwise operated has decreased from 0.79 ha. to 0.75 ha. and 1.19 ha. to 0.88 ha. respectively in 2015-16. Average operated area per operational holding as a whole decreased marginally from 0.79 ha. to 0.75 ha. in 2015-16.

It is observed that 78.44% of the number of operational holdings under the land tenure status of wholly owned and self operated area of marginal size category, operating 36.38% of the total operated area, while the small size category constituting 14.09% of number of operational holdings held 26.09% of the operated area.

The extent of operated area cultivated was 97.06% in 2015-16. The net area sown have shown a increase from 78.60% in 2010-11 to 79.55% in 2015-16. The area under current fallows has also marginally increased to 17.51% in the current census from 16.31% in the previous census.





It is observed from the above table 2.2.2, that Net area sown was highest with marginal holders and the lowest with the large holders and similarly it also holds good for net cultivated area.

The total uncultivated land accounted highest of 24.70% under the category of Semi-medium land holders while it was only 8.72% in the case of large holders.

It is estimated that 97.06% of the operated area in the state is under cultivation and the remaining 2.94% is either not cultivated or not available for cultivation.

2.3 Irrigation:

The estimated net sown area of the state during the agricultural year 2015-16 was 4832682 ha. of this, 2832774 ha were irrigated area accounting for 58.62% of the net sown area. (Source: Season & Crop Report 2015-16)

The operational holdings are classified by irrigation status into three groups viz., wholly irrigated, wholly unirrigated and partly irrigated. The following statement shows the percentage of holdings irrigated under various categories.

The table highlights that 41.38% of the total irrigated area are under marginal category while the large category accounted for only 3.33% of the irrigated area.



It is seen from the above Table 2.3.2 that the share of total operated area under each wholly irrigated and wholly unirrigated is descending with the same order of the holdings categories. With regard to the partly irrigated status, the share of operated area is least in large categories with 6.65% and highest at Semi-medium category with 29.39%.

In Table 2.3.3, the percentage of net area irrigated during the current census has decreased to 62.19% from 63.81% in previous census. Except large size class category all other categories has shown a slight decrease in irrigation.




Table - 2.3.4 A - Gross cropped area and Irrigated area in 2015-16



The statement 2.3.4B shows that cropping intensity has increased from 111 in 2010-11 to 123.68 in 2015-16. Similarly Irrigation Intensity also increased from 102.58 in the previous census to 123.91 in the current census.



In Table 2.3.5 the percentage of gross cropped area to operated area is maximum at 109% in the marginal category, while it is minimum at 74% in the large category. It is seen that the utilization of gross cropped area for raising food crops was 81% in marginal category and lowest of 57% in large category. The overall share of area under food crops has decreased from 79% in 2010-11 to 78% in 2015-16. Only under the large category of operational holdings, the share of area under food crops has increased from 54% in 2010-11 to 57% in 2015-16.

The overall share of area under non-food crops remain same except marginal & large category. Marginal category has shown a meager increase & Large category has shown a meager decrease.

CHAPTER - 3

COMPARATIVE ANALYSIS

This chapter compares vital aspects of 2015-16 Agricultural Census with that of previous census data, other States and All India figures.

The number of operational holdings have sharply increased by 26.24 lakhs in the course of 45 years from 1970-71 to 2015-16. The marginal holdings have witnessed a drastic increase from 31.25 lakhs to 62.24 lakhs over the past 45 years. On the other hand, large category holdings witnessed a negative percentage of holdings over the census years. Overall percentage of holdings have increased to 49.38% in the last 45 years.

The average size of operational holdings at all India level works out to 1.08 ha. which is just 0.75 ha in Tamil Nadu.(Table 3.6)

With the abolition of intermediary rights, tenants acquired proprietary rights in land and have been brought directly in relation with the State. This has contributed to increase in wholly owned and self operated holding. The above Table 3.7 reveals that the percentage number of wholly owned and self-operated holdings numbers have gone up from 92.23% in 1970-71 to 99.76% and area have gone up from 91.30% in 1970-71 to 99.58% in 2015-16.

In Table 3.9 the cropping pattern over the years shows a mixed trend with the production of food crops showing a gradual shift towards production of non-food crops (except oilseeds) while paddy still maintains the predominant place.

CHAPTER - 4

FACTORS INFLUENCING AGRICULTURE

This Chapter analyse some of the factors influencing Agricultural Census results.

4.1 Land Ceiling in Tamil Nadu:

Land is the main factor of production in agriculture and also the primary source of income and wealth in rural areas. Since inequality in the distribution of land is the basic cause of economic disparities and privileges, land reform aiming at a more equitable distribution of land forms the integral part of agrarian reforms. The existence of a large number of landless labour and concentration of land ownership have urged the planners and policy makers to impose a ceiling on agricultural land holdings. Laws were enacted for the redistribution of land to the landless poor with a view to reducing the concentration of land ownership and improving the socio-economic conditions of the weaker section of the population. The objective of the ceiling law is to acquire agricultural land held in excess of ceiling and to secure its subsequent redistribution to landless and other rural poor. In view of this, the State of Tamil Nadu played an important role and enacted legislations for the fixation of ceiling on holdings from time to time.

4.1.8 Impact of land ceiling :

Number of operational holdings have gone up from 53.14 lakhs in 1970-71 to 79.38 lakhs holding in 2015-16.

4.2 Area under forest : Depletion of forest area has affected the climatic pattern and rainfall. The run off rate of water has increased because there are now fewer trees to slow its downward course, which means less of the available rainfall percolating into the ground. Dwindling groundwater dries up the soil more rapidly and crops begin to wither much faster.







Executive Summary

The main findings of the Tenth Agricultural Census 2015-16 are given below:

1. There are 79.38 lakh operational holdings in Tamil Nadu, operating 59.71 lakh hectares as against 81.18 lakh operational holdings operated on an area of 64.88 lakh hectares during 2010-11. Both the Operational holdings and Operated area decreased over five years.
2. The average size of operational holdings for the State during the year 2015-16 stood at 0.75 ha as against 0.79 ha in 2010-11. Showing a decrease of 0.04%.
3. The percentage of cultivated land has marginally decreased from 95% in 2010-11 to 80% in 2015-16.
4. Most of the operational holdings area are under wholly owned and self operated category in the state, which is 8% lesser than the previous Census.
5. About 78.44% of the operational holdings under wholly owned and self operated category are marginal holders, which is 1.44 % higher than the previous Census.
6. Out of the total net cultivated area, marginal category of operational holdings shows a decrease from 36.40 % to 30.48% constituting the highest among the categories of holdings.
7. The percentage of gross cropped area to the total operated is highest at 109% in the marginal category while it is lowest at 74% in the large category.
8. Out of the total gross cropped area, 80.68% is under food crops in the case of marginal holdings whereas it is 57.32% for large holdings indicating the preference for cultivating non-food crops by large holdings owners.
9. The marginal holders (less than 1ha) constituted 78.40%, operating an area of 36.32 %. Which shows a slight increase from the Previous Census of 77.2% holders operating 35.33% of area.
10. The cropping intensity is highest at 131 in the case of marginal holdings and lowest at 102 in large category.
