Monthly Review of Wholesale Price Index (2011-12=100) of Tamil Nadu
June 2025 (Provisional) and May 2025 (Provisional)

Wholesale Prices for Agriculture and Non-Agricultural commodities are collected from 83 centres and the Wholesale Price Index of Tamil Nadu is computed and released every month with Base Year 2011-12=100. The Wholesale Price Index for Tamil Nādu is worked out under the three major groups viz., (I) Primary Articles, (II) Fuel & Power Sector and (III) Manufactured products with assigned weights of 22.45%, 15.59% and 61.96% respectively.

All Commodities:

The Wholesale Price Index of All Commodities for June 2025(P) stood at **172.74** as against **172.22** in May 2025(P) showing an increasing trend of **0.30%** over the previous month. In general, the increase in the Wholesale Price Index of All Commodities during June 2025(P) is due to an increase in the Major group's Index of Fuel & Power Sector and Manufactured Products.

Highlights

The month-over-month change in Wholesale Price Index for the month of June 2025(P) stood at 0.30% as compared to May 2025(P)

Primary Articles

Decreased by 0.13% due to a decrease in prices of Food Articles viz., Bengal Gram, Black Gram, Green Gram, Horse Gram, Tapioca, Ginger, Drumstick, Mango, Cashewnut, Lemon, Marine/Inland Fish, Black Pepper Chillies, Turmeric, Tea leaf, Cotton Kapas, Gingelly, Lime Stone and Natural Gas.



Fuel and Power Sector

Increased by 0.01% because of an increase in price of Coke under the subgroup of "Coal" and the prices of Furnace Oil under the subgroup of "Mineral Oils"



Manufactured products

Increased by 0.57% owing to a increase in the index of the Manufacture of Textiles, Leather and Leather Products, Paper and Paper Products, Chemical and Chemical Products, Other Non-Metallic Mineral Products, Electrical Equipment, Machinery & Equipment, Manufacture of Furniture and Other Manufacturing.



The Food Index has decreased by 0.86% when compared with previous month due to decrease in the price of Food Article's group of Pulses (Bengal Gram, Black Gram and horse Gram), Vegetables (Ginger, Tapioca and Drumsticks) Fruits (Mango, Cashewnut and Lemon) Marine/Inland Fish Condiments & Spices (Black Pepper and Turmeric and Tea leaf) and Manufacture of processing and preserving of fish and animal meat, Manufacture of Vegetable, animal oils & fats and Manufacture of Sugar & Molasses under the sub-group of Food Products.

I. Primary Articles:

The Wholesale Price Index of this major group decreased by 0.13% from **205.74** in May 2025(P) to **205.48** for June 2025(P). The Wholesale Price Index of sub groups viz., Food Articles (-0.29%), Minerals (-2.66%) and Crude Petroleum & Natural Gas (-5.53%) have decreased. While, the Non-Food Articles (1.72%) has increased in June 2025(P) when compared to May 2025(P) as given in Chart-1

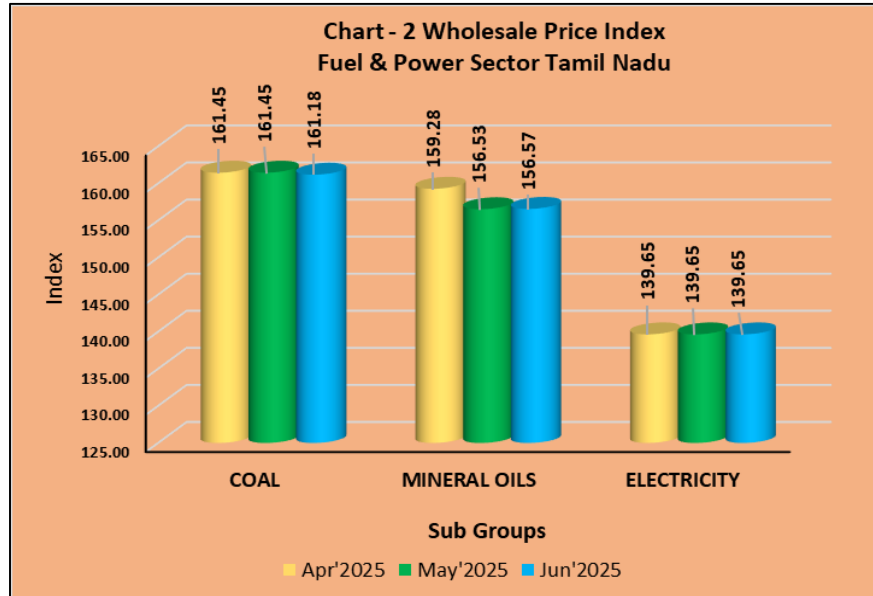
The decrease in the index is predominantly due to decrease in the prices of Bengal Gram (-1.19%), Black Gram (-2.05%), Red Gram (-0.59%), Green Gram (-0.31%), Horse Gram (-0.28%), Ginger (-2.36%), Drum Stick (-8.60%), Mango (-34.03%) Cashewnut (-7.56%), Lemon (-57.26%), Jack Fruit (-3.45%), Marine / Inland Fish (-3.07%), Black Pepper (-2.85%), Chillies (-1.24%), Turmeric (-2.17%), Tealeaf (-10.27%), Cotton Kapas (-1.88%), Gingelly (-6.97%), Lime Stone (-4.07) and Natural Gas (-7.90%).



The Wholesale Price Index of Cumbu (2.28%), Ragi (1.34%), Potato (10.63%), Onion (13.76%), Tomato (56.87%), Cauliflower (29.30%), Brinjal (40.56%), Lady's Finger (32.25%), Cabbage (15.93%), Carrot (27.76%), Beans (4.58%), Mushroom (6.39%), Grapes (12.97%), Pineapple (11.80%), Coconut (3.73%), Eggs (4.89%), Cardamom (4.33%), Garlic (19.82%), Tamarind (3.17%), Groundnut (5.52%), Sunflower (14.87%), Cotton Seed (9.80%) and Crude Petroleum (10.78%) have shown an increased trend during this month as compared with the previous month. A decrease in the prices of Pulses, Fruits, Fish & Meat, Condiments & Spices, Fibres, Flowers and Crude Petroleum & Natural Gas have contributed to decrease in the index of the Primary Articles group.

II. Fuel & Power:

The Fuel & Power group Index has increased by 0.01% and stood at 154.76 points for June 2025(P) as compared to May 2025(P). The sub group-wise index is depicted in Chart 2.



The groups and items showed variations during June 2025 (P) are as follows.

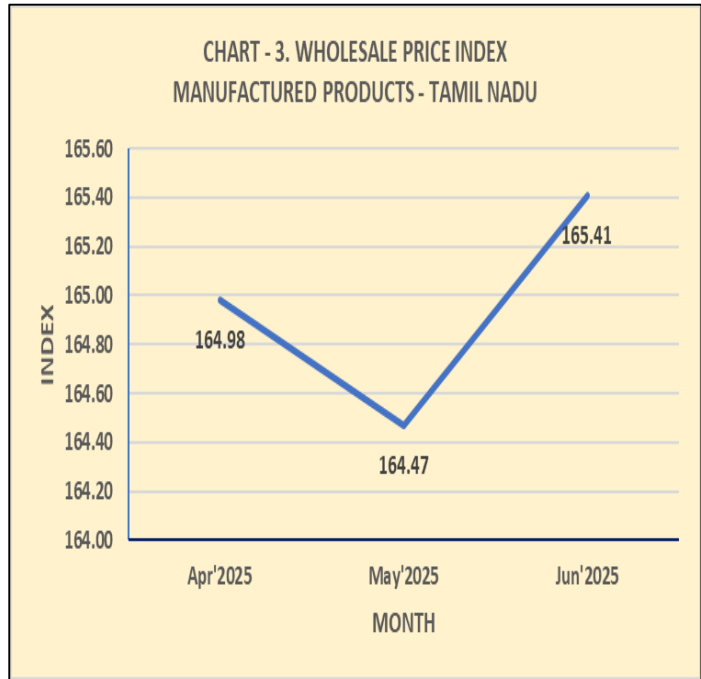
The “Mineral Oils” sub-group Index has increased by 0.03% over the previous month due a rise in the prices of Furnace Oil (4.18%).The sub-group of “Coal” Index has increased due to a rise in the prices of Coke (1.82%). While, the prices of Lignite, LPG (LPG-Domestic and LPG-Non-Domestic), Aviation Turbine Fuel (ATF) and Bitumen have decreased.

III. Manufactured Products:

The Manufactured Products group Index has increased by **0.57%** and stood at **165.41** points for June 2025(P) as compared to May 2025(P).Out of the sixteen sub-groups of Manufactured Products Index, twelve Sub-groups have increased and four sub-groups have decreased for June 2025(P)

The Wholesale Price Index of Manufactured Products for the last three months as shown in Chart 3 shows an increasing trend.

The month - over - month increase in the price is mainly attributed to the Group viz., Manufacture of Beverages & Tobacco Products, Textiles, Leather and Leather Products, Paper and Paper Products, Chemical and Chemical Products, Other Non-Metallic Mineral Products, Computer & Electronic Products, Electrical Equipment, Machinery & Equipment, Motor Vehicles, Trailers & Semi-Trailers Products, Manufacture of Furniture and Other Manufacturing Products.

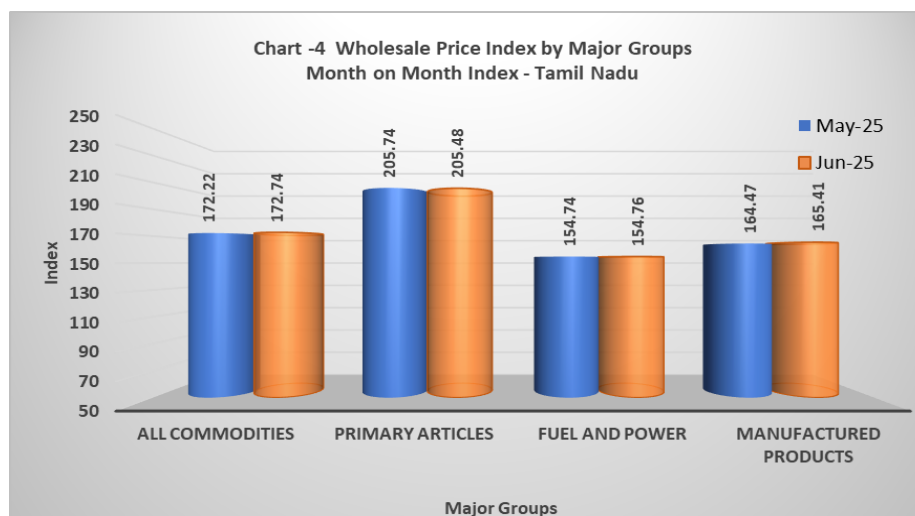


Some of the important groups that witnessed a decrease in the index are Manufacture of Food Products, Wood and Wood Products, Rubber & Plastic Products and Basic Metals & Fabricated Metal Products in June 2025 (Provisional) when compared to May 2025 (Provisional).

The month-over-month change in the Wholesale Price Index for June 2025 (P) stood at 0.30% compared to May 2025(P). The monthly changes in the WPI index for the last six months in Tamil Nadu are summarised below:

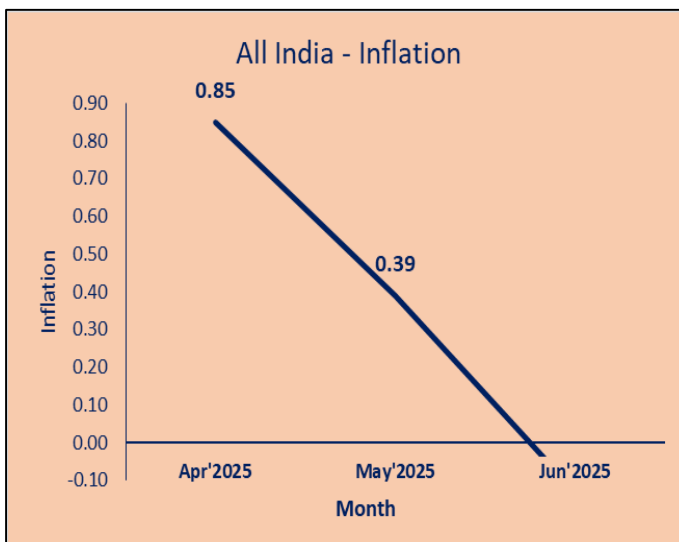
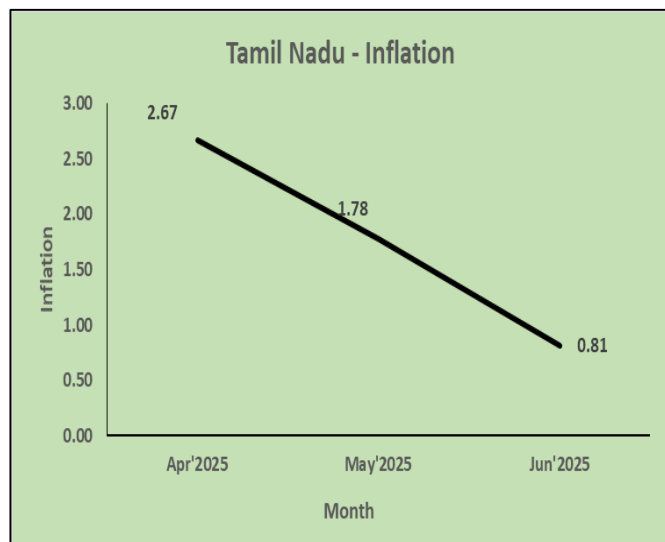

Year-over-Year Inflation Variation in Tamil Nadu:

The Annual Rate of Inflation in Tamil Nadu for 'All Commodities' of Wholesale Price Index (WPI) is 0.81% for June 2025(P) over June 2024(F) and the positive rate of inflation in June 2025(P) is mainly due to the increase in the major group of Manufactured Products which have recorded an inflation of 3.76%. While, the Primary Articles and Fuel & Power sector have decreased by 3.92% and 1.82% respectively.

The increase in the rate of Inflation in June 2025(P) is mainly due to an increase in the prices of Manufacture of Food Products, Beverages & Tobacco Products, Textiles, Leather & leather Products, Wood and Wood Products, Paper and Paper Products, Chemical & Chemical Products, Other Non – Metallic Mineral Products, Computer and Electronic Product, Electrical Equipment, Machinery and Equipment, Motor Vehicles, Trailers & Semi-Trailers, Manufacture of Furniture and Other Manufacturing Products under the group of "Manufactured Products".

The Wholesale Price Index of All Commodities at All India level for the past 3 months is shown in Chart-6.



The Wholesale Price Index of **‘All Commodities’** at the All India level decreased by 0.19% from 154.1 in May 2025(P) to 153.8 in June 2025(P).

At the All India level, month-over-month percentage change in the Index is seen in the major groups of Fuel & Power Sector and Manufactured Products which have decreased by 2.52% and 0.07% respectively and the Primary Articles has increased by 0.81% in June 2025(P) compared with May 2025 (Provisional).

The Month-over-Month variation of Food Index has decreased by 0.86% in June 2025(P) as compared with the previous provisional data for May 2025 (Table 6).

The Food Index, consisting of 'Food Articles' under the Primary Articles group and 'Food products' under the Manufactured Products group have decreased from 203.02 in May 2025(P) to 201.28 in June 2025(P) showing a decreasing trend of 0.86% in month-over-month variation. The year-over-year rate of inflation based on the WPI Food Index has decreased from 2.38% in May 2025(P) to -1.65% in June 2025(P). This is shown in Table 6a and Table 6b.

Conclusion:

The all commodities Wholesale Price Index of Tamil Nadu has increased by 0.30% for June 2025(P) which is stood at 172.74 points, due to a increase in the prices of Fuel & Power sector (0.01%) and Manufactured Products (0.57%) groups. While, decrease in the index of Primary Articles (-0.13%) compared with May 2025(P).

The annual rate of inflation based on the Tamil Nadu Wholesale Price Index (WPI) has increased is 0.81% for June 2025 (Provisional) over June 2024. The Positive rate of inflation during this month is primarily due to the increase in the prices of Manufactured Products.
